

# PEC - PLE



PEC and PEC-PLE refer to modalities of the Student Agreement Program (PEC), a Brazilian government program that aims to train and qualify international students in higher education institutions in Brazil. PEC-PLE is for Portuguese as a Foreign Language courses, generally offered as preparation for PEC-G, in higher education institutions for international students who wish to enroll in undergraduate or graduate courses in Brazil.

PEC-PLE (Portuguese as a Foreign Language):

- What is it?

A preparatory Portuguese course for foreign students who do not yet have the necessary proficiency to enter directly into undergraduate studies (PEC-G).

- Who can participate?

Candidates approved in PEC-G who did not reach the proficiency level in Portuguese required by the educational institution.

- Benefits:

Allows foreign students to acquire the Portuguese proficiency necessary to pursue undergraduate studies in Brazil.

- Requirements:

Generally, approval in PEC-G and lack of proof of proficiency in Portuguese.

PEC-PLE is a preparatory course that facilitates access to PEC-G for those who do not have the necessary proficiency in Portuguese. To learn more, [click here](#).

### Who can participate in PEC - PLE?

The Portuguese as a Foreign Language Student Agreement Program (PEC-PLE) is intended for candidates who intend to pursue an undergraduate degree in Brazil through PEC-G, but who are not from Portuguese-speaking countries and do not have proof of proficiency in the language. [📎](#)

### Necessary Documentation.

The original documents and documents relating to entry and regular stay in Brazil must be presented to the Undergraduate Student Exchange Program in Portuguese as a Foreign Language (PEC-PLE). They must be presented, accompanied by a copy of each, by the first day of class, according to the academic calendar. [📎](#)

### About the visa

A visa is a document issued by Brazilian Consular Representations abroad that allows foreigners to expect to enter and stay in the national territory, provided that the conditions set forth in current legislation are met. [📎](#)

## Frequently Asked Question

### • WHERE IS PEC-PLE OFFERED?

The course is taught at some Brazilian universities that participate in PEC-G and have Portuguese teaching programs for foreigners.

### • IS THE PEC-PLE STUDENT ALREADY ENROLLED AT UNIVERSITY?

No. The student will only be officially enrolled in the undergraduate course after completing the PEC-PLE and obtaining certification in the Celpe-Bras exam

### • WHAT HAPPENS IF THE STUDENT DOES NOT PASS THE CELPE-BRAS AT THE END OF THE PEC-PLE?

If the student is not approved, he/she will not be able to enter the undergraduate program and may need to return to his/her country.

### • CAN THE STUDENT REQUEST AN EXTENSION OF THE PEC-PLE?

An extension may be granted in exceptional cases, provided the student demonstrates progress in learning the language.

### • CAN A PEC-PLE STUDENT CHANGE UNIVERSITY AFTER COMPLETING THE COURSE?

No. The student must enter the same university where he/she was allocated by PEC-G.

### • IS PEC-PLE MANDATORY FOR ALL PEC-G CANDIDATES?

No. Only candidates who do not demonstrate sufficient proficiency in Celpe-Bras need to take it.
